***Aether is pleased to report the following activity for the month of March:***

***In April, Aether continued to focus on preparing evaluation samples for testing partners. Samples for the Asian tier-one supplier were synthesized and will ship imminently. Samples for the North American aftermarket manufacturer were completed, qualified and shipped. They will be testing both our automotive and small motors catalysts in standardized on-vehicle tests. The samples have been received and evaluation results are expected during May.***

***in anticipation of the testing of our second JDA sample, the test reactor has been undergoing preparative maintenance and calibration and Aether has been adding to the baseline of relevant chemistries. The Company has shipped its second batch of catalyst to our JDA partner and is awaiting its processing and return for testing; our partner has advised us of a significant backlog on their fibre line and hopes to have processed samples back to us for testing in early June.***
